Old business: Berwick Property: A motion was made by Mrs. Bailey and a second was made by Mr. Caffery to authorize the Director to proceed with the purchase of the Berwick property provided the property would be purchased for \$30,000 or less. Motion carried. Facilities Maintenance Master Plan was briefly discussed.

Director's report: Staff training took place on Dec 1, 2017. Dear Reader was demonstrated by the sales rep via a webinar, Victoria Simoneaux spoke about ways to invest, why to invest and vague generalities of types of insurances and why you might want them. BV cameras system was discussed earlier. Amelia repairs still looking to get the roof and the decorative soffit changed.
